# SU90 2017 CAMPOREEE Troop Leader

#### PLEASE READ IMPORTANT POINTS BELOW NOT TO BE MISSED

> Troops are responsible for bringing their own snack for Friday Nights S'more kick-off which will be held in the pavilion (behind the cabins). We will have several grills to share do our snack on as well as picnic tables for the girls. Please bring 1 bag of Easy Lite Charcoal. S'more "long sticks from ShopRite" are suggested too!

Note:

Troops will provide their own snacks at their designated picnic table for Friday night as well as Snacks if wanted during the day/night Saturday in your cabins.

\*\* This is being done by troop so that there are no concerns regarding food allergies and sharing and troops know their girls likes/dislikes so they will be happy with the troop selection of snacks.

Troop's leaders are responsible for preparing the FINAL TROOP CAMP PACKET and delivering it to Mary McAdams at 8 Rosewood Lane in Washington. PACKETS ARE TO BE AT MY HOUSE NO LATER THAN MARCH 30<sup>TH</sup>. Please be sure to include the Troop Summary/Roster and Troop Overnight application, girl forms and a copy of the troop Medical Records for each camper. Please have your checklist on top of your packet and indicate your Troop # and Check # for our records.

Note: It's a good idea to give your parents a deadline whether you email, text or phone them to pick up the camp paperwork to be completed with a return date so we do not have any delays.

Late reservations are not guaranteed a spot at Camporee. This year we are open to two Service Units on a "First Come... First Serve" basis. So get your registrations in early.

- Troops are responsible for providing 1 SWAP per registered scout camper There will be a final count given to all leaders by April 15<sup>th</sup>. SWAP Ceremony will be held Saturday to include all Daisy's.
- Troop leaders are responsible for making troop parents aware that Cross Roads is a Nut Free Facility (all food is homemade). There will be only one separate area with Peanut Butter & Jelly as a meal substitute for campers. If scouts have particular food allergies please make sure it is noted on the registrations.
- Troop leaders are responsible for submitting a copy of all campers medical forms in one envelope marked with your troop number and needs to be given at registration for the Nurse on duty all weekend. All troop medical form packets are to be picked up prior to departure or can be picked up at SU90 Treasurers house after camp.
- ➤ Each troop should travel with a small First Aid kit for minor injuries. Kits should be stored in the troop cabin/tent. A nurse will be on staff the entire weekend Cabin will be designated with First Aid Sign.
- > One troop leader or representative for your troop should be designated to the registration area/parking lot to gather girls for your troop as they arrive and check in upon arrival. Troops are to check in together, please instruct your girls to wait for their entire troop or leader in charge before their parents leave. Girls cannot check into cabin without a leader or parent volunteer attending camp.

#### **CAMP PAYMENT AND REFUND POLICY PAYMENT**

Camporee payment is to be PAID IN FULL at the time of registration. There will be a \$25 non refundable payment in the event a camper needs to cancel her registration. This non refundable portion of payment will be used to cover the cost of shirts as well as other misc costs which are planned prior to final count to ensure we have all the supplies needed.

First Payment is due in full by March 30, 2016. Troops are to submit payment for all the girls attending in their troop at one time and in an envelope with registration for each camper attached. All payments are to be dropped off or mailed to our Service Unit Treasurer and Camp Committee Members home:

If payment is not received by March 34st, your troop space may not be available. This year's Camporee is on a FIRST COME FIRST SERVE basis for registration because we are open to another Service Unit as well for Camporee 2017.

REFUNDS • Requests for refunds (-\$25 non refundable deposit) must be submitted in writing to mcadams-94681-leader@tyflm.net at least 4 weeks in advance of the camp start date for consideration.

Refunds may take up to six weeks for processing.

Refunds for cancellations occurring less than 4 weeks in advance are only considered in cases of emergency and are handled on a case-by-case basis. These requests must be submitted within 7 days of the camp start date for consideration.

Refunds are NOT issued for early departures or late arrivals to/from camp, campers who choose not to stay at camp, campers considered "no shows" (those who do not attend and did not give advance notification of cancellation), or for days missed during a camp session.

Paper registration closes on March 30, 2017 to ensure adequate time to the camp start date for all orders and Camporee prep to be made.

Any girl/leader/volunteer wishing to attend a SU90 2017 Camporee must be an active Girl Scout during the camp year so please be sure to check that everyone who wishes to attend is registered and have the proper paperwork attached.

### **Girl Scout Camp Code of Conduct**

Dear Camper and Parent(s)/Guardian(s):

Girl Scouts Heart of NJ, Service Unit 90 strives to provide quality learning opportunities for girls and is committed to creating a violence-free environment where girls can grow strong. Girl Scouts attending summer camp are expected to live by the Girl Scout Promise and Law. Prior to attending camp, girls and parents are expected to review the Promise, Law, and the Code of Conduct below:

#### **Code of Conduct**

- 1. Respect and cooperate with girls and counselors in your unit and throughout camp. Make an effort to get to know girls in your unit and try to find ways to include other girls.
- 2. Tell a counselor if you are having a problem at camp. It's okay to tell if you (or someone you care about) are having trouble getting along with another camper, are frightened, don't feel well, or miss your family.
- 3. Disagreements at camp will be settled by talking through the problem. Adults at camp will help girls to discuss their differences and find solutions.
- 4. Offensive or abusive language is not permitted.
- 5. Physical threats, physical violence, aggressive behavior, destructive behavior and/or threats of destructive behavior will be taken seriously and not tolerated.
- 6. Self destructive or abusive threats or actions will be taken seriously.
- 7. Harassment (teasing) of other campers will not be tolerated.
- 8. Use or possession of alcohol, recreational drugs, tobacco is illegal and therefore, prohibited.
- 9. Cell phones are prohibited at camp. Cell phones will be confiscated and returned to parents at the end of the session.

Parents of girls who do not meet the expectations for appropriate behavior will be notified. If the Camp Team or Leaders determines that a camper's behavior is unmanageable, parents will be notified and the camper will be sent home. Girls and parents are asked to read and discuss the Girl Scout Promise, the Girl Scout Law, and the Code of Conduct and to sign this document that they understand their responsibilities:

We have read and understand the above expectations. We have discussed appropriate behavior at camp. We understand that if a camper exhibits inappropriate behavior, parents will be notified and informed of the consequences of her actions. This could include her removal from camp.

I understand that if I do not pick up my daughter within reasonable time or make arrangements for her pick-up, local children and youth authorities will be contacted.
